Call for Abstracts

APTA LA Fall Meeting Research Presentations Session

The APTA LA will host a Research Presentation section as part of the CEU session on the Friday evening of the upcoming Fall Meeting (August 25-27, 2023). The one-hour Research Presentations Session will consist of four platform presentations, and simultaneous poster presentations. All are encouraged to apply for participation including PTs, PTAs, PT students, and PTA students. Submissions will be reviewed and accepted by the Research Chair/Committee, with assistance from the APTA LA Board as necessary. Platform and poster presentations will be accepted based upon quality of the work, and the desire to provide a diverse selection of presentations. Completed research projects are preferred; however, case reports and proposed studies/theory designs are acceptable. Any submission that is not used in the presentation for CEU credits will be encouraged to be presented in poster format.

Abstract Submission Deadline: Friday, June 30, 2023 at 11:59PM

All abstracts must be submitted via e-mail to Daniel Flowers, APTA LA Research Chair: daniel.flowers@lsuhs.edu.

Formatting Requirements for Abstracts:

A structured abstract of no more than 250 words, with references provided, is required. The word count does not include title, author names, or references. Citations may follow any professional guidelines, as long as they are consistent and correct. For formal research projects, the sections should include: Background, Methods, Results, and Discussion/Conclusions. For Case Reports or Proposed Study/Theory, the sections should include: Background, Design/Case/Theory, and Discussion.

The abstract should include a title, all authors, the abstract itself, and references. The authors should indicate whether they are submitting for a platform or poster presentation immediately after the abstract, and if applying for a platform presentation, whether they would be willing to provide a poster presentation if not accepted for a platform. Only four platform submissions will be accepted due to time constraints.

All completed projects/reports with human participants must include a statement indicating the project received Institutional Review Board approval or exemption.

Introduction to Musculoskeletal Ultrasound (MSKUS): Benefits from a Physical Therapist's Perspective

Saturday-Sunday, August 26-27, 2023

COURSE DESCRIPTION:

MSKUS is becoming a very formidable diagnostic modality worldwide. Financial implications of advanced modality options such as CT and MRI, combined with the increased costs of healthcare generically, are pushing the focus toward more Point of Care Ultrasound (POCUS) options.

The ACPA, APTA and ARDMS are eager to accept physical therapists to obtain Registry in Musculoskeletal Ultrasound (RMSK). St Tammany Health System has embraced this challenge in a big way, having four PTs achieve this national certification with another twelve working toward this endeavor.

The goal of this course is to provide interested therapists with a hands-on/lab-based introduction of this diagnostic modality, learning anatomy in a new way that ties it to pathology in real time, statically and dynamically. During this course the team will also strive to give participants real-world scenarios to explain the benefits of this modality for Physical Therapists in Acute, Emergency Room and Outpatient settings, showing benefits for our patients as well as how it can strengthen the position of the clinician.

Objectives:

At the conclusion of this course, the participant will be able to:

- 1. Identify areas in my practice setting where Musculoskeletal Ultrasound (MSKUS) provides benefit to the patient population
- 2. Demonstrate understanding of basic ultrasound physics
- 3. Demonstrate understanding of normal Shoulder / Knee Sono-anatomy
- 4. Demonstrate areas of benefit in utilizing MSKUS in diagnosing shoulder and knee pathology

COURSE INSTRUCTORS:

Jay Morange, PT, DPT, RMSK, MBA is the Director Outpatient Operations at St. Tammany Health System (STHS). He has been in the field for almost nine years graduating from LSUHSC-New Orleans in 2014 with a Doctorate of Physical Therapy. Jay has been heavily involved in STPH's Non-Pharmacological Opioid Alternatives program along with a collaboration of a multi-disciplinary effort to address the Opioid Epidemic, going on to present at the local, state, and national levels. Continuing the journey through innovation, he completed his registry in musculoskeletal ultrasound (RMSK) in November 2021. This PT has aspirations to continue leadership in healthcare with a focus on research and education to increase quality, innovation, and safety in the healthcare field.

Bert Lindsey PT, RMSK, Director Rehab Services and Pt Mobility STPH, is considered a SME on Non-Pharmacological Pain Alternatives, speaking in administrative conferences nationally and publishing a Squire Report for CMS in 2019. Together with Jay Morange, their work on Dry Needling in Acute led to interest in MSKUS as a way to reduce opioid exposure by way of accelerating diagnosis of injury.

Diagnostic Imaging: The Why, The What and The How for Practitioners, Educators and Advocacy Efforts

Saturday-Sunday, August 26-27, 2023

COURSE DESCRIPTION:

What should physical therapists know about diagnostic imaging to deliver appropriate patient management, including maximizing patient outcomes? This question is relevant to clinicians, educators and those advocating on behalf of our profession. This course will provide physical therapists with a thorough understanding of diagnostic imaging principles and strategies that can be immediately integrated into one's clinical practice and will provide academic and clinical educators with an understanding of methods to integrate important imaging content into student/resident/fellow educational experiences. Last, this course will provide strategies for those advocating for the physical therapists' ability to order imaging in legislative and health systems arenas.

The major thrust of the course will be on musculoskeletal imaging and the content will be delivered via interactive educational experiences, mixed with lectures and patient case examples. The overall goal is to prepare our clinicians

for the appropriate utilization of diagnostic imaging and as such existing clinical guidelines will be emphasized and the American College of Radiology (ACR) Appropriateness Criteria resource will be explored.

Objectives:

At the conclusion of this course, the participant will be able to:

- 1. Describe strengths and limitations of plain film radiography, CT and MRI
- 2. Identify normal skeletal anatomy on plain films for the spine and selected extremity regions
- 3. Describe and implement the imaging guidelines for patients post-trauma and with those with potential serious medical conditions, and the ACR guidelines for patients with low back, neck, hip, knee, and shoulder pain.
- 4. Evaluate plain film findings associated with fractures in order to establish an appropriate patient prognosis
- 5. Describe the elements of an appropriate referral to a radiologist
- 6. Describe methods to integrate diagnostic imaging content within the academic and clinical education curricula
- 7. Describe strategies to effectively advocate for physical therapists referring patients directly for imaging

COURSE INSTRUCTOR:

Bill Boissonnault, is professor-emeritus at the University of Wisconsin-Madison and holds multiple adjunct physical therapy faculty positions. Previous positions include Executive VP of Professional Affairs, APTA. He received his PT degree from the University of WI-Madison, his MS and DHSc degree from the University of St. Augustine, and his t-DPT degree from Massachusetts General Hospital Institute of Health Professions. Dr. Boissonnault has presented nationally and internationally on topics related to diagnostic imaging, medical screening, and direct access. He has taught diagnostic imaging content in entry-level DPT and orthopedic residency programs, and chaired the APTA Wisconsin X-ray task force that led to passage of bills allowing physical therapists to order plain films. He is editor of the textbook- Primary Care for the Physical Therapist; Examination and Triage, and he has multiple journal publications related to differential diagnosis, diagnostic imaging, manual therapy, and patient direct access. Dr. Boissonnault served as president of the Orthopaedic Section, APTA, and the Foundation for Physical Therapy Research. He received the APTA's Baethke-Carlin Award for Excellence in Academic Teaching, and Lucy Blair Service Award, the Education Section's Distinguished Educator Award, and the UW-Madison Medical School Dean's Teaching Award for Excellence and Innovation in Medical Education. He was named a Catherine Worthingham Fellow of the APTA, and Fellow of the American Academy of Orthopaedic Manual Physical Therapists.
